

Holiday Giveaway Rules & Entry

Great Lakes Credit Union (“GLCU”) Official Rules:

“It’s On Us” Holiday Shopping Giveaway

November 16, 2020 to January 17, 2021
(Up to \$250 to cover debit/credit card transactions)

No Purchase Necessary to Enter or Win.

Eligibility: “It’s On Us” Holiday Shopping (“Giveaway”) is open to U.S. residents 18 years of age or older. The drawing is not offered to GLCU employees, officers, Board of Directors and members of their immediate families (spouse, civil union partner, parent, grandparent, child, sibling and any in-law relationship.). This contest is subject to applicable federal, state, and local laws and regulations. Void where prohibited.

How to Enter: Members with a debit and/or credit card will be entered to win up to \$250 to cover debit/credit card transactions each week from November 16, 2020 to January 17, 2021.

Winner Selection: One winner will be chosen at random each week, and announced every Friday from all entries received through the prior Sunday, beginning November 16, 2020. Odds of winning depend on the total number of eligible entries. All decisions are final and binding in all contest matters. The winner will be notified by telephone, email, and/or letter within 30 days after the drawing. If the winner cannot be contacted, is ineligible, or fails to claim the prize within 30 days from the award notification, the prize may be forfeited and an alternate winner selected.

No purchase is necessary to win. Entrants may receive entries through mail in submission of the attached form (no more than one submission per week allowable). Additional entries will be received per each purchase made with a GLCU debit and / or credit transaction during the time period of the contest dates.
